**Item No. 3:**      **To consider and decide the Review Application received from following colleges for fixation of fees for AY 2014-15.**

**1)DPH 6477:**      **Shree Vasantrao Banduji Patil Trust's Appasaheb Birnale College of Pharmacy, Sangli.**

Heard the Institute. The Notice as per our resolution was given, but none is present on behalf of the students/parents.

This is in respect of the course started during 2014-15. The fee declared for 2013-14 was Rs. 55,000/-. The fee declared for 2014-15 is Rs. 56,200/-. This is challenged. The interim fee declared was Rs. 57,750/-. The Institute has raised the point regarding the Non-consideration of DA difference paid. To some extents there is substance in it. It is now submitted that atleast the fee should be Rs. 57,750/-. A letter dated 2/2/2015 is given to that effect. It is reasonable. We approve Rs. 57,750/-. Office to declare.

**2)AR 6534 :**      **Shri. V.B. Patil Trust's Appasaheb Birnale College of Architecture, Sangli.**

Heard the Institute. The Notice as per our resolution was given, but none is present on behalf of the students/parents.

This is in respect of the course started during 2014-15. The fee declared for 2013-14 was Rs. 60,450/-. The fee declared for 2014-15 is Rs. 57,100/-. The point submitted in respect of deduction of salary is very high. There is some substance in it. The Institute has stated that atleast Rs. 60,450/- to be declared as fee. The letter to that effect dated 2/2/2015 is given. We accept and approve the fee of Rs. 60,450/-. Office to declare it.

**3)EN 3216 :**      **Gharda Foundation's Gharda Institute of Technology, Khed, Ratnagiri.**

Heard the Institute.

They pray for withdrawal with liberty to file a fresh one, if necessary. Allowed to withdraw accordingly.

**4)PH4160 :**      **VYWS's Institute of Pharmaceutical Education & Research, Wardha**

Heard the Institute. The Notice as per our resolution was given, but none is present on behalf of the students/parents.

This is in respect of the course started during 2014-15. The fee approved for the course started during 2013-14 was Rs. 75,000/-. The fee approved for the course started during 2014-15 is Rs. 81,000/-. It is challenged. It is challenged only on the ground that salary deduction of 19% is very high. We feel that there is some



substance in this. The deduction should have been around 8% to 9%. The Institute has now given a letter dated 2/2/2015 stating that their fee may be approved at Rs. 85,000/-. It is reasonable. We approve the same. Office to declare it.

**5) MP4160 : VYWS's Institute of Pharmaceutical Education & Research, Wardha**

Heard the Institute. The Notice as per our resolution was given, but none is present on behalf of the students/parents.

This is in respect of the course started during 2014-15. The fee approved for the course started during 2014-15 was Rs. 108000/-. The fee approved for the course started during 2014-15 is Rs. 1,15,000/-. It is challenged . It is contended that the salary disallowance of 30% is extremely high. There is some substance in it. The Institute has now given letter dated 2/2/2015 stating that their fee may be approved at Rs. 1,18,000/-. It is reasonable. We approve the same. Office to declare it.

**6)HM6540 & M.HMCT : Maharashtra State Institute of Hotel Management & Catering Technology, Pune.**

None is present on behalf of the Institute. Notice by the office was given to the Institute by post as well as on Website. Hence dismissed for default .

**7)EN6289 : B.R.A.C.T's Vishwakarma Institute of Information Technology, Kondhwa (Bk), Pune.**

Heard the Institute. The Notice as per our resolution was given, but none is present on behalf of the students/parents.

The fee approved for the course started during 2013-14 was Rs. 95,000/-. The fee declared for the course started during 2014-15 was Rs. 99,750/-. It is challenged. The point raised is disallowance of salary of 14%. It is submitted that it is on higher side. There is some substance in this. The Institute has now given a letter dated 2/2/2015 stating that the fee may be approved at Rs. 1,03,000/-. It is reasonable. We approve the same. Office to declare it.

**8)EN6273 : Bansilal Ramnath Agarawal Charitable Trust's Vishwakarma Institute Technology, Bibwewadi, Pune.**

Heard the Institute.

They prayed for withdrawal of this revision. Allowed to withdraw .





**9)PL5230 : Shri. Neminath Jain Bramhacharyasharam's Shri.  
H.H.J.B. Polytechnic Chandwad.**

Heard the Institute. The Notice as per our resolution was given, but none is present on behalf of the students/parents.

The fee declared for the course started during 2013-14 was Rs. 34,900/-. The fee declared for 2014-15 course is Rs. 39,000/-. It is challenged. The main point raised in respect of deduction of 15% salary. There is some substance in it. The deduction is on higher side. If we consider the same, the fees would be a little more than Rs. 40,000/-. The Institute has now given letter dated 2/2/2015 stating that it may be approved at Rs. 40,000/-. We approve the same. Office to declare.

**10)MB6116 : Bansilal Ramnath Agarawal Charitable Trust's  
Vishwakarma Institute of Management, Pune.**

Heard the Institute. The Notice as per our resolution was given, but none is present on behalf of the students/parents.

This is in respect of the course started during 2014-15. The fee approved for 2013-14 course was Rs. 1,36,930/-. The fee approved for the course started during 2014-15 is Rs. 1,44,000/-. It is challenged. It is challenged on the ground that the salary deduction is wrongly been made on higher side. There is some substance in it. The Institute has now given a letter stating that their fee may be approved at Rs. 1,48,000/-. It is reasonable. We approve the same. Office to declare.

**Item No.4: To consider and decide on the letter dated 16/6/2014 received from K.C. College of Engineering & Management Studies & Research explaining the query raised. (Ref: Item No. 5 of minutes 26/8/2014 & Item NO. 7 of minutes 17/9/2014)**

There was complaint made in respect of the Engineering course and the Management course run by the Institute. In respect of the Engineering course resolution dated 17/9/2014 at item No 7 was already passed. But there was no mention made in it about the management course. The fee in respect of management course is the same as in the case of engineering course. The fee declared for the management course for 2013-14 was Rs. 1,26,500/- . The deduction would be required to be made out of this for the 2 points raised i.e. credit for accreditation & credit for International prizes . The deduction would be of Rs. 6,600/-. Therefore the fee declared should have been Rs. 1,19,900/-. The excess fee recovered to be refunded immediately to the students. Office to declare and reply also.



**Item No. 5: Any other matter with the permission of the chair .**

Office had pointed out 2 errors in the figures mentioned in "Item No. 4 (iii): To consider and decide on the letter dated 10/11/2014 received from K.C. College of Engineering & Management Studies & Research in furtherance of a Ref. Item No. 4(i) of minutes 17/10/2014" of the resolution dated 2/12/2014. The error is in line No. 3. It should be 60 instead of 120. And in line No. 4 it should be 120 instead of 240. Office to communicate it.
