The Fees Regulating Authority had decided to open the link for submission of online fees proposals for the academic year 2024-2025 w.e.f 02/10/2023 & the Institutions were given time till 31/10/2023, which was lastly extended upto 30/11/2023.

Inspite of granting time till 30/11/2023 some of the Institutions again approached the Authority and requested to extend the period. On due consideration of their request the period was extended upto 15/12/2023.

The Institutions mentioned below who failed to submit proposal within the period prescribed have send letters of request to extend the period for submitting proposals and open the link to facilitate them to submit proposals or to record online intimation to opt for No Upward Revision of fees.


On due consideration of the request received and consequences to follow on account of non submission of proposal/intimation and more particularly the difficulties to be faced by the students to apply for reimbursement of fees, it was decided to provide opportunity to Institutions mentioned above subject to penalty of Rs. 1 lakh per course for submitting proposal for upward revision of fees and Rs. 5,000/- per course for recording intimation to opt for no upward revision of fees for the academic year 2024-2025. The payment of penalty shall be condition precedent to entertain the proposal.

The link be made open w.e.f 22/04/2024 and same shall be kept open till 15/05/2024 for submission of online proposal for upward revision of fees for the academic year 2024-2025 as well as to record intimation to opt for no upward revision of fees.

Let the follow-up action taken be accordingly".
