Item No.1(ii):

To consider the proposal for approval of fees of the L.L.B. 5 course for the academic year 2022-2023 submitted by the Ibsar School of Law, Karjat.

"Discussed.

Inspite of notice the Principal and Management running the Institute failed to respond the notice dated 16/10/2023. The Institute has not deposited the penalty nor submitted hard copy of the proposal. The explanation as directed not furnished. In absence of deposit of penalty and compliance the fees proposals of the Institute cannot be decided. List subject for consideration after two weeks to decide the further course of action against the Institute which include recommending the name of the Institute to affiliating Authority for appropriate action.

Item No.1(iii):

To consider the proposal for approval of fees of the P.B.Sc. (Nursing) course for the academic year 2023- 2024 submitted by the Sushrusha Institute of Nursing Sciences, Pune (PBSCN0019). "Discussed."

Inspite of repeated direction the Institute has not reported the compliance. In absence of the information and the documents the Authority is unable to decide the fees proposal of the Institute. The Institute be directed to report the compliance within one week. Failure to comply the notice be issued to the Principal of the college and the members of the Management running the Institute to personally appear before the Authority and show cause as to why penal action as contemplated u/s. 20 of the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees) Act, 2015 may not be taken against them.

Let the follow up action be taken accordingly".

Item No.1(iv):

To consider the proposal for approval of fees of the P.B.Sc. (Nursing) course for the academic year 2023-2024 submitted by the Namco College of Nursing & Research Institute, Nashik (PBSCN0041).

"Discussed.

The Institute though seeking approval of fees for the academic year 2023-2024 in respect of P.B.Sc (Nursing) but wrongly shown the course as B.Sc.(Nursing). Unless the Institute rectify the mistake the Authority cannot decide the fees proposal. It was decided to permit the Institute to submit fresh online proposal by way of rectification of mistake within two weeks. The Link be made open to the Institute for re-submission of proposal of P.B.Sc. (Nursing) instead of B.Sc.(Nursing).

The link be made open w.e.f 06/11/2023 and same shall remain open till 28/11/2023.

Let the follow up action be taken accordingly".

Item No.1(v):

To consider the proposal for approval of fees of the B.Sc.Nursing course for the academic year 2023- 2024 submitted by the Siddhagiri Nursing Institute, Kolhapur (BSCN09180).

"Discussed.

The Institute has submitted the proposal for approval of fees for the academic year 2023-2024. Since it was noticed that the Institute has not submitted the proposal for approval of fee for the academic year 2022-2023 as mandatory requirement u/s. 14 (1)(a) of the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and



Fees) Act, 2015 the show cause notice was issued to the Institute as per the decision taken in the meeting of the Authority held on 25/10/2023. Inspite of notice the Principal and the Management running the Institute failed to respond to notice. In absence of submission of fees proposal for the academic year 2022-2023 the fees proposal of the academic year 2023-2024 cannot be taken into consideration. The Principal and the Management running the Institute be informed to report the compliance within one week. Failure to compliance the Principal and the Management running the Institute liable for proceeding u/s. 20 of the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees) Act, 2015 which includes imposition of penalty and recommending the name of the Institute to affiliation Authority for appropriate action.

Let the follow up action be taken accordingly".

Item No.1(vi):

To consider the proposal for approval of fees of the B.Arch course for the academic year 2023-2024 submitted by the Indala School of Architecture, Thane (AR3507).

"Discussed."

The Principal of the Institute has requested time to comply the direction on account of non availability of Chartered Accountant representing the Institute. The Institute be directed to report the compliance within one week . Failure to compliance the Authority will be constraint to proceed with the matter.

Let the follow up action be taken accordingly".

Item No.1(vii): To consider the proposal for approval of fees of the B.Pharm course for the academic year 2023- 2024 submitted by the Sumantai Institute of Pharmacy, Jalgaon (PH5472).
