Item No. 2: To discuss on letters received from the colleges / institutes regarding No Upward Revision for A.Y. 2021-22 and continue the same fee of A.Y. 2019-20.

Item No. 3: To discuss in the matter of complaint received from the students of N.L. Dalmia Institute of Management Studies and Research College, Mira Road (Ref: Item No. 7 (i) in the meeting dated 13th October 2020).

For the A.Y. 2019-20 approved fees for MBA course is Rs. 1,87,000/-. The students produced the receipts showing collection of fees for A.Y. 2019-20 for other fees Rs. 2,28,000/-, application form fee Rs. 2,000/- in addition to tuition fee Rs. 1,67,713/- and development fee Rs. 19,287/-. Prima-facie, excess collection is Rs. 2,30,000/-. The response of the college was invited vide email dated 19/10/2020. Smt. Seema Saini, the Principal of the college, was invited to interact with the Authority through video conferencing on 20/10/2020. She has her own justification to offer. She has been asked to submit her say in writing immediately.

Discussed. The adhoc fee declared is for all the new colleges and not for any particular college. It is noticed that from the students admitted against Institutional / NRI quota, fees in multiples are collected. This has an impact on an overall fee structure which is confirmed on receipt of the proposal. Keeping in view the above, adhoc fee has been recommended.
