- i) **In the matter of deciding fee structure of Smt. Sharadchandrika Suresh Patil College of Pharmacy, Chopda, Dist Jalgaon for AY 2003-04 and 2004-05 as direction of Hon'ble High Court Aurangabad Bench in W.P. No. 6629 of 2005, decided on 22/8/2017.**

The Petitioner is conducting 4 years B. Pharmacy course since 1992. The Petitioner-Smt. Sharadchandrika Suresh Patil College of Pharmacy, Chopda submitted proposal for approval of fee structure to the then Shikshan Shulka Samiti. Pending decision, the college collected interim fee at Rs. 35,000/- per year per student. The Shikshan Shulka Samiti declared following fee structure –

Academic Year	Final fees
2003-04	Rs. 21,100/-
2004-05	Rs. 23,000/-

Aggrieved by this, the Petitioner filed W.P. No. 6629 of 2005 before Hon'ble High Court at Aurangabad. On 22/8/2017 Hon'ble High Court decided the W.P. with the

direction to this Authority to determine the fees to be charged by the Petitioner for its B. Pharmacy Course for the year 2003-04 and 2004-05, after hearing the Petitioner.


The Petitioner's contention, of allowing 15 times monthly salary as total salary expenditure being not in conformity with norms specified, cannot be accepted. Actual amount paid towards salary for the year 2003-04 and 2004-05 is allowed. All other contentions of petitioner are accepted. Revised fees based on the then existing methodology for the year **2003-04 and 2004-05 works out to Rs. 30,000/- and 33,500/- respectively.**
