Heard.

On the previous date, the hearing was adjourned to enable the officials to produce the documents. The officials present seeks a further three weeks' time to produce the documents including Form No. A1 and A2 as directed earlier.

The Institute has submitted the proposal showing students admitted during the period 2017-2018, 2018-2019, 2019-2020 and 2020-2021 as zero which resulted in no vacancy allowance awarded to the Institute. The officials submitted that as against the intake capacity of 320 students, the Institute has admitted 178 students during the said period and there was inadvertent mistake in submitting the proposal on the part of the Institute. Similarly, the officials submitted that the payment of salary to staff was made through Bank transfer. The Chartered Accountant has wrongly mentioned in its report that the salary was paid in cash. Due to a mistake on the part of the Chartered Accountant, the Authority has made the disallowance from the salary expenses. It is further submitted that the additional income of Rs. 12,52,348/- shown in the proposal, in fact the fees charged prior to 2018-2019 as per the fees approved by the MCAER. Therefore, the said amount is not an additional income generated by way of fees charged over and above the fees approved by the Fees Regulating Authority. It is therefore submitted that the said amount was wrongly treated as additional income.



In order to clarify the position and produce supporting evidence, requested the hearing is adjourned.

The Institute is directed to produce the documents such as Form No. A1 and A2 in prescribed proforma duly filled in and signed by the Chartered Accountant who audited the accounts and issued the Audit Report, Form No. 24Q along with Form No. 16 and 16A, complete Audited Financial Statements of Financial Year 2020-2021 showing separately Income and Expenses of the Institute/College of the Food Technology. In case separate audited Income and Expenditure are not prepared by the Chartered Accountant while issuing the report then submit the correct segmental of bifurcation of Income and Expenditure of Food Technology Institute. Also, submit the list of students from whom the amount of Rs. 12,58,438/- received as fees as per the fees approved by the MCAER. The compliance be made on or before 08/02/2023.

Adjourn as a last chance to 08/02/2023."
