To consider the Review Applications received from the College/ Institute running the courses mentioned below as against the fees approved by the Authority for the academic year 2023-2024.

- (H) Review Application No. 32/2023 filed by Nutan College of Engineering And Research, Pune (EN6419).
  "The following were present:-

In brief it is contended that the Authority has erred in disallowing expenses to the extent of 50% to 75% claimed under the heads of the gardening expenses , lab material, demonstration material, consumables, prospectus printing & training & placement by observing excessive. It is urged to allow the expenses to full extent.

On scrutiny of the submission advanced it is noticed that the disallowances made by the Authority are fully justified and no case is made out to revise the fees. During the course of hearing and the scrutiny of the audited financial statement it is noticed that the amount to the tune of Rs. 2 Crores which is shown as rent paid in the Income and expenditure account infact clubbed and shown as expenses of prospectus, printing, demonstration material , lab material, gardening expenses inflate the expenditure and claim higher fees. There was deliberate attempt to mislead the Authority by clubbing the inadmissible expenses of rent under the heads of the gardening expenses , lab material, demonstration material, consumables, prospectus printing & training & placement.

In view of above no case is made out to entertain the Review Application. The Review Application filed is devoid of merit. Hence the application is rejected.

The Officials of the Institution are warned from indulging into such act of clubbing inadmissible expenses under the heads of



admissible expenses to claim higher fees. The repetition of such act would be viewed seriously".
