No. 5: To discuss in the matter of finalizing norms for academic year 2019-20.

Interest on loan:

Issue of allowing interest on loan raised by the institute was under consideration of the Authority. A Committee to deliberate on this issue was constituted. In that representatives of the institutes were invited. Having considered all the aspects and fact that, institute being unaided – raising loan to meet revenue expenditure is not a taboo; therefore, has to be considered. While considering expenditure incurred towards payment of interest, interest of the students community cannot be ignored. Thus striking balance between interest of the management and the stakeholders following is decided.

"Interest on Bank loan would be considered as expenditure subject to upper limit of 2% (two percent) of the Total Revenue Expenditure (before charging the interest) as approved by this Authority for a given academic year and for a given course, per student. Such interest would be considered as admissible only on satisfactory evidence and for the purpose of payment of salaries and other revenue expenditure. Interest on loans for the proposes of Capital Expenditure such as building, equipments etc. would not be considered. However, interest on TEQUIP loans (World Bank Scheme) would continue to be considered as allowable

Item No. 6: Any other matter with the permission of chair.

i) To consider the letter dated 29/6/2018 received from Aamdar Kashinathji Mengal Polytechnic, Igatpuri, Dist- Nashik regarding finalization of fees structure.

Peculiar case of making request to retain same fees since 2015-16. Having considered the representative of Aamdar Kashinathji Mengal Polytechnic the fees for the year 2018-19 shall be Rs. 33,000/-. In the previous A.Y. 2016-17 fees was Rs. 34,000/-. This shall be subject to payment of processing fees.
