The Officials submitted that there was a mistake on the part of Institute in submitting online proposal as well as submission of hard copy of the proposal. Due to mistake on the part of the Officials of the Institute the expenses claimed under the caption of affiliation fee, repair and maintenance of the building, repairs and maintenance to equipment, vehicles, computers, etc. has been disallowed. Although the Institute has made the expenditure the certificate came to be issued under the seal and signature of Principal of the Institute that no such expenditure was made in the financial year 2021-2022 and therefore submission of documents not applicable. The Officials requested to allow the Institute to rectify its mistake and produce the supporting documents with break up of item wise expenditure.

It is pointed out to the Officials that the Institute has not furnished the break up of amount claimed as repair and maintenance of the building. As against the spending of Rs. 5,400/- per student on salary of teaching and non teaching staff, the Institute has claimed Rs. 22,000/- per student as



expenses made for repairs and maintenance of the building which to be charged as the fees from L.L.B. 3 years course students. Similarly, as against the spending of Rs. 3,246/- per student towards salary of teaching and non teaching staff the amount claimed towards repairs and maintenance of the building approximately Rs. 11,000/- per student and same to be charged as fees from L.L.B. 5 years students. Although it is expected that non salary expenditure shall not to exceed 30% to 40% of the salary expenditure the spending on repairs and maintenance is about 3 to 4 times the expenditure made on salary expenditure.

The Officials submitted that due to Covid-19 the functioning of the Institute was closed and therefore the Institute was required to spend more money on repair and maintenance .

In view of above the Institute is directed to submit the information and documents as under:

- To file an affidavit of Principal and the President/Secretary of the Trust clarifying the circumtances under which the Institute has made a statement in writing in the proposal that no expenses made in the financial year 2021-2022 on items referred above & claimed as expenditure.
- To submit the authentic documents in the nature of receipts of payment made towards expenditure claimed towards payment of affiliation fees and other expenses.
- 3. To sumbit the item wise list of the amount paid as professional charges, expenditure of advertisement, expenses claimed as affiliation fees paid to affiliation Authority, repairs and maintenances of furniture equipment, vehicle, computer, with supporting bill of expenditure. Item wise list of repair made to building with particulars of expenditure & the supporting evidence such as bills of payment with G.S.T paid, T.D.S deducted etc. be submitted.
- To submit the Audited Financial Statements of the Institute duly signed by Chartered Accountant of last three years prior to financial year 2021-2022 and audited financial statement of 2022-2023.

The Complaince as directed above be made on and before 08/12/2023.
