At the out set the reasons assigned are totally unacceptable and unsustainable in law. It is a mandate of law that the proposal for approval of fees to be submitted within a period prescribed u/s. 14(1)(a) of the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees)Act, 2015 (hereinafter referred to as the said 'Act of 2015'). There is no provision under the Act of 2015 providing immunity from submitting the proposal pending the Review Applications. In that view the request for submission of proposal after expiry of the period provided for submission of proposal deserves to be rejected. However looking to the fact that the institutions were acting under misconception of law, the Authority is of the view the opportunity be given to institutions mentioned above to submit the proposal to over come the difficulties faced by the institutions as well as the students in absence of approval of fees by the Fees Regulating Authority. It was therefore decided to allow the Institutions mentioned above to submit the proposal by opening the link.

The link be made open w.e.f 22/04/2024 and same shall be kept open till 15/05/2024. It is expressly made clear that non submission of proposal within a period prescribed the Institutions will liable for proceeding u/s. 20 of the said act 2015.

Let the follow-up action be taken accordingly".
