The college started in the A.Y. 2016-17. The college was asked to submit fees proposal for A.Y. 2018-19 & get the adhoc fees of previous A.Y. i.e. 2016-17 & 2017-18 approved. The college failed to do so. So far as fees for subsequent A.Y. i.e. 2019-20 & 2020-21 is concerned, no fees proposals have been submitted. This is clear contravention of the provisions of Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees ) Act, 2015.

Therefore, it is hereby directed that the college should appear before this Authority on 19/3/2020 through their representative and show cause why penalty according to law be not imposed on them.

**Item No. 4: In the matter of declaration of Adhoc fees for MDMS (MBBS-PG) for A.Y. 2020-2021.**

Communication received from SMBT Institute of Medical Sciences and Research Centre, Nashik. There may be other similarly situated colleges. Process of PG admission has started. Previous academic years Adhoc fee was Rs. 9,50,000/-.
