Item No.1(ii): To consider the letter of request received from the Unaided Private Professional Institutions/Colleges to open the link to submit the online proposal for approval of fees (Upward Revision of fees) or opt for No Upward Revision of fees for the academic year 2023-2024.

“Discussed.

The Fees Regulating Authority had decided to open the link for submission of online proposals for approval of fees for the academic year 2023-2024 w.e.f 06/10/2022 & the Institutions were given time till 31/10/2022 for submission of online proposals, which was extended upto 30/11/2022.

Inspite of granting time till 30/11/2022 some of the Institutions again requested to extend the period. On consideration of their request the period was extended upto 31/01/2023 with penalty of Rs. 50,000/- per course for submitting proposal for upward revision of fees and Rs. 5,000/- for online recording of intimation to opt for No Upward revision of fees.

On and after 01/02/2023, the Institutions mentioned below have send letters seeking permission to submit the online proposal & open the link to facilitate them to submit proposals or to record online intimation to opt for No Upward Revision of fees.


On due consideration of the request received from the Institutions mentioned above and difficulties to be faced by the students on account of non submission of proposal/intimation to secure reimbursement of fees , it was decided to provide one more opportunity to Institutions mentioned above to submit the online proposal seeking upward revision of fees for the academic year 2023-2024 subject to penalty of Rs. 2 lakh per course and penalty of Rs. 5,000/- per course for recording intimation to opt for no upward revision of fees for the academic year 2023-2024. The payment of penalty shall act as condition precedent to entertain the proposals seeking upward revision of fees as well as intimation to opt for no upward revision of fees.

The link be made open w.e.f 22/04/2024 and same shall be kept open till 15/05/2024.
