In Review Application No. 18 of 2021 filed by Florence Nightingale Training College of Nursing (RGNM0197) –Wardha the Institution/College has filed the application to withdraw the Review Application. The Application seeking withdrawal of the Review Application is taken on record. Mrs. I.P. Alwadkar, the Principal of the college and Mr. Brajesh Lohiya, the Finance Officer and the person authorized to represent the Institute submit that they have taken instructions from the Management to withdraw the application.

It was decided to allow the Institution to withdraw the application and dismissed the same as withdrawn.

In Review Application No. 19 of 2021 filed by New Mother Teresa (RANM 0272) Nursing School, Udgir, Latur, the Institution has sent a letter dated 23/9/2021 through email to withdraw the Review Application. A copy of the letter taken on record.

Hence, the Review Application is dismissed as withdrawn.

In Review Application No. 20 of 2021 filed by Helen Rose School of Nursing (RGNM0017), Umri, Yavatmal, Mrs. Shilpa K. the Principal of the College, Nursing School appeared and requested to alow the Institute to resubmit the proposal for approval of fees. She submit that the Institution is in existence from 2002. All the transactions of the Institution are made through Bank, the salary of teaching and non teaching staff are paid through bank account. So also most of the students studying in their institute are from Tribal Community. She was detected Covid-19 positive and therefore required to proceed on leave. In her absence the Vice Principal of the Nursing School has submitted the proposal. She has committed mistake in submitting the proposal. Incase the Institution, is not allowed to re-submit the proposal, it may cause serious prejudice to Institution as well as the Tribal students.



Considering the submission made it was decided to defer the hearing of the Review Application. The Institute/College is directed to submit the proposal along with requisite documents in physical form within two weeks. The Proposal to be submitted must provide segmental bifurcation of expenses incurred in respect of RANM & RGNM courses.
