- 5) Full Audited Financial Statements from financial year 2020-2021, 2021-2022 & 2022-2023.
- 6) Statement of the amount claimed toward reimbursement of fees from categories of SC, ST, VJNT, OBC, EBC & TFWS and the amount received from the State Government by providing the year-wise breakup from 2020-2021 & 2021-2022 in respect of B.Pharm course as well as M.Pharm course".

Item No.4:

To consider the proposal for approval of fees of Rajarshi Shahu College of Law, Vikroli, Mumbai run by Abhay Shikshan Kandra's, (LLB3050) for approval of fees for the academic year 2021-2022 & 2022-2023.

"The following were present:

The Officials present submitted that in compliance of the direction given by the Fees Regulating Authority, the Institute has refunded total amount of Rs. 55,78,500/- to the students studying in the college. Out of said amount the amount of Rs. 34,87,100/- has been refunded to the students mentioned in list annexure 'A' through RTGS/NEFT/Cheque. The particulars of names of the students, the amount refunded, to individual student the mode of refund as well as receipts issued by students in acknowledgment of payment received are submitted as Annexure 'A' with the affidavit dated 11/01/2023 filed by the Principal of the Institute. The balance amount of Rs. 20,91,400/- has been refunded by way of adjustment fees of next academic year of the students studying in the college. The detailed particulars of the students such as name of individual students, the amount refunded by way of adjustment and copies of the receipts are



produced as Annexure 'B' with the affidavit dated 11/01/2023 filed by the Principal of the Institute.

It is submitted that as the Institute has complied the direction and refunded the excess fee recovered to the students studying in the college. In view of compliance of direction, the proposals of the Institute for approval of fees for the academic year 2021-2022 & 2022-2023 be finalised.

In terms of sec 13(2)(iii) of the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees) Act, 2015 (hereinafter referred to as 'the said Act 2015') the Authority is vested with the powers to redress the grievance of the stakeholders. The term 'Stake-holders' referred in sec 13(2) (iii) of said Act 2015 has been defined u/s. 2 (w) of the said Act, 2015, which reads as under;

"Stake-holders" means the management, the students studying in the respective institution and their parents,

Thus the term 'Stake-holders' as defined u/s. 2 (w) of the said Act, 2015 restricts to students studying in the college and their parents. In that view, the Institue has redressed the grievance of Stake-holders i.e. the students studying in the college by refunding the excess fees recovered from them. Prima-facie the students who have left the college are not covered in the ambit of word 'stakeholders' defined u/s. 2 (w) of the said Act, 2015.

The Institue has refunded the excess fees recovered from the students studying in the College. In support of the submission made the Institue has filed the affidavit and also produced the photocopies of cheques, receipts etc. In that view the proposals of the Institute for approval of fees of the academic year 2021-2022 & 2022-2023 deserves to be finalised.

In view of above it was decided to finalize and approve the fees of the Institute for the academic year 2021-2022 & 2022-2023 subject to condition that the Principal and the Chairman of the Institute shall file an affidavit to effect that in the event if any claim is raised as to non-refund of excess fee recovered from the students studying in the college then the Institute shall refund the excess fee to such students within one week from the date of receipt of such claim.

On due consideration of the proposal submitted the affidavit produced in support of the proposal and further taken into consideration the



refund of excess fee to the students studying in the College it was decided to finalised and approve the fees of the Institute for the academic year 2021-2022 & 2022-2023 subject to filing of Affidavit in above term as under:-
