In brief, it is the contention of the officials present that the software has computed the fees of Rs. 43,645/- per student. The Authority has approved the fees of Rs. 26,500/- per student only. The fees as approved is

very meagre and insufficient to run the course, it is submitted the Authority has disallowed the expenditure claimed towards visiting, repairs, expenses related to students, other expenses as well as rent and depreciation.

On due consideration of the submission advanced and grounds raised in the Review Application, the Authority is of the view that the Review application filed as devoid of merit.

The disallowances made by the software on account of building repairs, expenses related to students and other expenses claimed under the wrong head were already considered and allowed by the Authority while approving the fees in the meeting of the Authority held on 21/09/2022. In that view the contention raised by the Institute deserves no consideration.

So far as the depreciation of Rs. 9,20,028/- claimed by the Institute, the depreciation of Rs. 6,09,274/- has been already allowed as per the FRA norms on the basis of information provided by the Institute in the proposal. The depreciation has been worked out by the software and said amount has been included in the fees decided by the Authority.

The amount of Rs. 37,80,000/- has been allowed as usage charges to the institute as per FRA norms while assessing the fees. Since the usage charges are assessed and included in the fees determining, there is no question of claiming rent as an expenditure by the Institute.

In view of the above, the Review Application filed by the Institute/College is devoid of merit and liable to be rejected. Accordingly, the Review Application is rejected.
