Item No. 2: In the matter Fees of B.Sc Honours for Academic Year 2020-21 for Unaided Private Professional Colleges under Agriculture Universities.

Read the letter dated 12th March, 2020 received from Director Education (MCAER), Pune stating that B.Sc. (Hons) (Agri. Business Management) course has been declared as "Professional Education" from the academic year 2020-21 and to decide fee structure of the said course for the said academic year. As per the scheme of the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions Fees) Act, 2015, time limit for receipt of the proposals for the fees for A.Y. 2020-21 was till 31st October 2019. Entire process relating to fees for A.Y. 2020-21 is over. Now, FRA has to start for preparation to receive fees proposals for the A.Y. 2021-22. Further, while deciding fee structure of any new course it is necessary to get conversant with staffing pattern teaching and non-teaching, infrastructure required and other details. On that basis FRA makes addition in the existing norms. In view of this the authority concerned shall proceed to decide fees for A.Y. 2020-21 for B.Sc. (Hons) (Agri Business Management) as was being done till the previous academic year. While inviting proposals for A.Y. 2021-22 we shall invite the fees proposals for the course B.Sc. (Hons) (Agri Business Management) after finalization of norms. The authority concerned shall provide

to this office details like staffing pattern, infrastructure including laboratories required, practice followed in granting approval to the appointment of teaching staff, broad estimate of non-salary expenditure etc. FRA is required to give thought to all these details and discuss it with experts in that field before proceeding to decide the fee structure of any new course.

Office to communicate this resolution to the authority concerned.

The Academic year 2021-22, the institutes are required to submit online fees proposals before 31st October 2020.

Item No. 3: To discuss the matter regarding online service for academic year 2021-22 & call the quotation from the appropriate agencies.

- (a) The Authority approves proposal for calling quotations with the monetary limit of Rs. 3 Lakhs only including taxes, for Server, Server Administration Support & Services, Database Administration for a period of one year.
- (b) The Authority approves proposal for calling quotations with the monetary limit of Rs. 3 Lakhs only including taxes, for Payment Gateway Support & Service for review application & technical support for Information Technology & Software Modification as per norms of the Authority for a period of one year.
