After providing the opportunity of hearing to the person/persons representing the colleges/institutes mentioned below, it was decided to revise their fees as under:-

Review Application No. PH-22/23 filed by the NDMVP Samaj's College of Pharmacy, Nashik (MP5005).

"Discussed.

The Institute has preferred the Review Application with the contention that the Authority has erred in adding the amount of Rs. 20,01,390/- as other income while deciding the fees proposal in the academic year 2021-2022.

In brief, it is the contention of the Institute that the amount of Rs. 20,01,390/- was received from Yashwantrao Chavan Maharashtra Open University (YCMOU) and Admission Round Council (ARC) Centre for certain projects and research work. The said amount was spent in the earlier



financial year i.e. 2018-2019 and the grant was received in the financial year 2019-2020.

For this reason, consideration of the said amount as additional income from the students deserves to be reconsidered.

It is further contention of the Institute that the Institute has incurred the expenditure to the tune of Rs. 9,77,540/- on visiting faculties and remuneration paid to non-teaching staff pertaining to the M. Pharm course run by the Institute. According to the Institute, the expenditure claimed towards payment of visiting faculties ought to have been allowed to the extent claimed in the proposal.

The Principal of the Institute as well as Chartered Accountant are absent. The officials present are unable to respond to the queries raised during the course of the hearing. So also they have not brought the record pertaining to the receipt of the amount of Rs. 20,01,390/- and corresponding payments made. They have also not brought the record pertaining to the names of the visiting faculties, the amount paid to individuals and the mode of payment to support their contention.

In order to properly present the case and to enable the Institute to keep the responsible officers and Chartered Accountant present for the hearing, the hearing is adjourned to 7/7/2022.

Review Application No.DPH-22/24 filed by Swasthyadarpan Pratishthan's Shantiniketan College of Pharmacy, Nagpur (DPH5454).

"Discussed.

The Principal of the Institute has sent email dated 30/06/2022 and requested to allow their Institute to withdraw the Review Application.

Allowed to withdraw.

The Review Application is disposed of as withdrawn."

Review Application No. DPH-22/25 filed by the Sarsam College of Pharmacy, Baramati, District-Pune (DPH6933).

"Discussed.

The President of the Trust submitted that the then Principal of the Institute has committed a number of mistakes in submitted the proposal. He submitted that salary to teaching and non-teaching staff except few one was paid through bank transfer/NEFT but in the proposal submitted, the same has been mentioned as "paid in cash". Due to this reason, the Authority has disallowed the salary expenditure to the extent of 50%. He further submitted that the fees finally determined by the Authority is less than the ad hoc fees. It resulted in causing serious prejudice to the Institute.

Perusal of the grounds raised in the Review Application reflects that no such plea has been raised in the Review Application. The submission made finds no pleading and grounds in the Review Application preferred by the Institute.

The Chairman of the Institute submitted that the Institute is newly established. They were not aware of the procedural aspect. Therefore, the mistake was committed.

It was decided to grant time to the Institute to raise additional ground by filing an affidavit.

The Chairman of the Institute is directed to file affidavit clarifying the position and produce the documents in supporting the evidence. The affidavit be filed within one week.

In the event compliance is made, list the Review Application for further hearing after two weeks.
