The Authority has examined the proposals received from the institutes/colleges mentioned below seeking approval of fees for the academic year 2020-21. After considering the individual proposal in the light of scrutiny report and considered all the relevant factors, for determinations of fee structure, it was decided to approve the fee structure of the colleges/institutes mentioned below as under;

The fees as approved be communicated to the individual institutes/colleges. The Institutes/colleges be informed that if the fee approved by the Authority is not acceptable to them then individual institutes/colleges may file the Review Application with detailed reasons to review the fees approved. The Review Application be filed as per the procedure prescribed, within fifteen days from the date of communication of the decision/fees approved.

The fees as approved is the maximum fees that can be charged and recovered from the students by the respective colleges/institutes. The term fees has been defined under section 2(g) of the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees) Act, 2015, the fees approved and includes tuition fee, gymkhana fee, examination fee, library fee, development fee, laboratory fee, information brochure fee, the



amount collected for any curricular or co-curricular activities and any other amount collected from the students, by whatsoever name and accepted in whichever manner, from the students/candidate admitted to professional courses by the Private Professional Educational Institution excluding any charges payable towards use of optional facilities such as hostel accommodation, mess charges and students insurance fees. Thus any amount accepted by the institutions in cash or kind, directly or indirectly in excess of fee approved by the Authority amounts to an Act of "profiteering" as defined under section 2(s) of the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees) Act, 2015 and liable for penal action as provided u/s 20 of the said Act of 2015.

Part II

On due consideration of the proposal received from Padmavati Nursing School, Aurangabad RGNM0198 it was found that the proposal was not properly submitted with requisite information. It was decided to direct the Institute/College to resubmit the proposal within two weeks.

Let the follow up action be taken accordingly ".

Item No. 2: To consider the request seeking No Upward Revision of fees for the academic year 2021-22 (list annexed as annexure 'A').

"Discussed.

The Management of the Unaided Private Professional Educational Institutions/colleges mentioned in the list **Annexure 'A'** have submitted online proposals seeking no upward revision of fees for the academic year 2021-2022 & continue to apply the fee approved for the previous academic year 2020-2021 for the academic year 2021-2022.

As per section 14(1)(b) of the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions & Fees) Act, 2015 in the event of non-submission of the proposal for upward revision of fee by the Management within the period prescribed u/s. 14(1)(a) of the said Act, the fee structure approved by the Authority & applicable during the previous academic year shall continue to apply to such institution for the immediate next academic year. Section 14(1) a & b of the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees) Act, 2015 read as under;

ly

- "14. (1) In determining the reasonableness of fee structure, the following provisions shall apply:-
- "(a) the Management of the Unaided Institution shall submit the details of the proposed fee alongwith the audited accounts of the preceding financial year, the proposed budget in respect of the current financial year and the relevant record and evidence to the Fees Regulating Authority for its approval not later than 31st October of previous academic year;
- (b) in the event of non-submission of the proposal for upward revision of fees to the Fees Regulating Authority within the time-limit specified by the Authority, the fees structure as approved by the Authority and applicable during the previous academic year shall continue to apply".

In view of the above, no specific order of the Authority is required to apply the fee structure approved by the Authority for the previous academic year for the immediate next academic year. Therefore the Management has to act in accordance with Law.

The list **Annexure 'A'** shall form the part & parcel of the minutes of the meeting.

Item No.3: To take decision to open the link for submission of proposal for the academic year 2022-2023.

"Discussed.

The Colleges/Institutions have submitted the proposal seeking upward Revision of fees for the academic year 2021-22. In meantime the fees of both Colleges finalized by the Authority for the academic year 2020-21.

In view of finalization and approval of fees for the academic year 2020-2021 the colleges mentioned above have requested to allow them to charge the fees for academic year 2021-22 as per fees approved for previous academic year 2020-21 i.e. Rs. 54,000/- for RANM course and Rs. 63,000/- for RGNM course by treating their proposal as withdrawn.

It was decided to allow both the colleges/institutes to withdraw their proposals seeking upward revision and to continue to charge the fees for RANM/RGNM course run by their colleges as per fees approved by the Authority for the previous academic year i.e. 2020-2021.

Let the follow up action be taken accordingly ".

Item No. 5: Any other subject with the permission of the Chair.

(a) To consider the letter dated 22/10/2021 received from Holy Spirit Institute of Nursing Education, Mumbai running RGNM courses to open the link to withdraw the fees proposal submitted for the academic year 2021-22 & continue to apply the fees structure for the academic year 2021-22.

It was decided to allow the college to withdraw the proposal submitted seeking upward revision of fees for the academic year 2021-22 and to retain the fees approved for the academic year 2020-21 for the academic year 2021-22 for RGNM course run by the Institute/College.

The Colleges/Institutes ought to have submitted the proposal on or before 31/10/2020. Considering the unprecedented situation crop up due to Pandemic of Covid 19, the Authority extended the period up to 20/1/2021. After the lapse of more than one year, the period prescribed for submission of the proposal the above-mentioned colleges have failed to submit the proposal. There is delay of more than one year in seeking permission to submit proposal.

In the larger interest of justice, it was decided to open the link up to 30/11/2021 subject to payment of penalty of Rs. 50,000/- to be paid by each of the colleges/institutes. The payment of penalty shall be condition precedent to entertain the application. It is expressly made clear that no further request for extension shall be entertained. In case the colleges/institutes mentioned above failed to submit proposals on & before 30/11/2021 the show cause notices be issued to them seeking explanation as to why the action as contemplated u/s. 20 of the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees) Act, 2015 be not initiated against them.

Let the follow up action be taken accordingly ".

(c) To consider the letter received from the RANM/RGNM institutes/colleges regarding open the link for submission of fees proposals for academic year 2020-21 and 2021-22.

"Discussed.

It was brought to notice that in spite of giving repeated extensions of time the colleges mentioned above failed to submit the proposal for approval of fees.

The Authority in its meeting held on 2^{nd} & 3^{rd} September, 2021 extended the period as the last chance subject to penalty of Rs. 5,000/- per course. The Authority has recorded as under;

"Considering the difficulties expressed by the colleges/institutes mentioned in list 'A' & 'B' running RANM/RGNM courses and taking note of difficulties faced by the colleges/institutes on account of unprecedented situation crop up due to pandemic of Covid-19, it is decided to extend the time limit for submission of proposal upto 30/9/2021.

It is further decided that the benefit of extension of time limit to submit proposal upto 30/9/2021, also be extended to those colleges/institutes running the RGNM/RANM courses but failed to submit the proposal within time subject to payment of penalty of Rs. 5,000/- per course.

It is further decided no further request seeking extension of time to submit proposals be entertained from any such colleges/institutes. If any colleges/institutes running RANM/RGNM courses failed to submit the proposal inspite of extension of time limit then the list of such colleges be placed before the Authority for taking action u/s 20 of the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees) Act, 2015".

In spite of repeated extension & specific direction, the Colleges/Institutes mentioned above failed to submit proposals within the period extended. They have once again approached the Authority for extension of time to submit proposal online. No cause has been assigned to condone the delay.

In the larger interest of justice and to safeguard the interest of students it was decided to extend the time to submit the proposal till 30/11/2021 as a last chance, subject to the penalty of Rs. 50,000/- per course. The payment of penalty shall be precondition to entertain the proposal. Incase the Colleges/Institutes mentioned above failed to submit the proposal on and before 30/11/2021, a show-cause notice be issued to them seeking explanation as to why the penal action as contemplated u/s. 20 of the



Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees) Act, 2015 be not initiated against them.

Let the follow up action be taken accordingly ".

(d) To consider the letter dated 21/9/2021 received from Dr. J.J.

Magdum Homoeopathic Medical College, Kolhapur regarding retention of fees for the academic year 2021-22, which was approved for the year 2020-21.

"Discussed.

It was brought to the notice of the Authority that in the meeting held on 2nd & 3rd September 2021 while considering of the subject no. 3 it was wrongly recorded that Dr. J. J. Magdum Homoeopathic Medical College, Kolhapur has second time opted for no upward revision. Due to mistake their request for continuation of fees approved for the previous year was rejected. It was pointed out that the request from said college was for retention of fees approved for the previous year 2020-2021 for the academic year 2021-2022 and therefore same ought to have been considered.

Considering the mistake the earlier decision taken in the meeting dated 2^{nd} & 3^{rd} September 2021 is recalled to the extent of said college. It was decided to allow the college to retain the fees of Rs. 85,000/- approved for the academic year 2020-2021 for the academic year 2021-2022.

The necessary Corrigendum be issued to rectify the mistake. Let the follow up action be taken accordingly ".

FEES REGULATING AUTHORITY STATE OF MAHARASHTRA
