Item No.1: To consider the Review Application No. BDS-22/02 filed by the Nanded Rural Dental College and Research Center, Nanded (BDS0025) for the academic year 2021-2022.

Discussed.

In compliance of the directions given on the previous date, the Chief Finance and Legal Advisor of the Institute appeared and filed affidavits of the Chairman of the Trust and the Chartered Accountant. The affidavits filed by them are taken on record.


The Chairman of the Institute has offered an explanation that there was an inadvertent mistake made on the part of the staff of the Institute as well as the Chartered Accountant in showing the amount of Rs.97,73,213/- as the amount received towards locker rent in the financial year 2019-2020. In fact, the said amount includes Rs.89,66,213/- as OPD receipts of Nanded Rural Dental College. The Institute has received the sum of Rs.5,83,500/- as locker rent from the students admitted in the Dental College run by their Trust and Rs.2,23,500/- from the students admitted in Physiotherapy College run by their Trust. As per the commitment made, the Institute has refunded the amount of Rs.8,61,500/- in the bank accounts of the students of Dental Institute and Rs.43,000/- refunded to the students of Physiotherapy Institute run by their Trust. Due to difficulty in securing the bank particulars of some of the students who have left the college, the balance amount could not be transferred to their respective accounts. However, the Institute is in process to secure the bank particulars of the students by approaching their parents.

Advocate Mr. Sanjay Kumar Sharma, the Chief Finance and Legal Advisor of the Institute has made a statement that the balance amount of Rs.15,14,500/- payable to the students admitted in Dental Institute and Rs.4,80,000/- to the students admitted in Physiotherapy Institute shall be refunded within four weeks. Statement is accepted.

The Institute is directed to refund the balance amount payable, as aforesaid, within four weeks and report compliance within four weeks thereafter.

The Institute has submitted an application seeking permission to withdraw the Review Application.

The Review Application is disposed of as withdrawn.

Hearing of the subject was concluded on 28.06.2022. At that time, the officials of the Institute requested for time to seek instructions from the Management to withdraw the Review Application.


The Principal of the Institute has sent email on 29.06.2022 seeking permission to withdraw the Review Application.
