While scrutinizing the proposal , it is noticed that the Institute has not submitted the proposal for the academic year 2022-2023. Hence explanation be called of the Principal & the Management as to why an action should not be taken u/s. 20 of the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees) Act, 2015.

In the proposal submitted for the academic year 2023-2024 it is noticed that though the names of faculty are shown in the proposal the Institute has not



shown corresponding annual salary of the individual staff. The Institute has also not furnished the fees collected during the academic year 2020-2021, 2021-2022 & 2022-2023. Although the Institute has claimed the expenditure like affiliation fees, inspection charges, examination fees etc, the receipts are not uploaded. So also the supporting documents in respect of other documents were not produced. It was therefore decided to call the necessary information to finalised the proposal for the academic year 2023-2024 & action to be taken in respect of non submission of fee proposal for the academic year 2022-2023. The explanation and requisite documents and information be directed to be furnished within seven days.
