Item No.4: To consider the proposal for approval of fees in respect of the M.B.A course for the academic year 2023-2024 submitted by the Arihant Institute of Business Management, Bawdhan, Pune (MB6626).

The Deputy Director of the Institute submitted that there was inadvertent mistake on the part of the Institute in submitting the proposal for approval of fees of M.B.A course. The income and expenditure of certification course run by the Institute has been included in income and expenditure shown in the proposal submitted for the approval of fees for the academic year 2023-2024. It is submitted that amount of Rs. 2,04,85,577/- shown as additional income in fact receipt of fees from Certification course which was voluntarily joined by the students. The income and expenditure of said course though required to be shown in the proposal under the head of Non F.R.A course same was shown as income & expenditure in respect of M.B.A course. The segmental bifurcation of expenditure in respect of M.B.A course and Non F.R.A course was not shown in the proposal. The Deputy Director of the Institute requested the Authority to open the link to enable the Institute to resubmit the on-line proposal with segmental bifurcation of the income & expenses of M.B.A course and Non F.R.A. course.

The Deputy Director of the Institute is directed to file the detailed affidavit explaining how the amount of Rs. 2,04,85,577/- shown as additional income & other expenses relating to Non F.R.A course included in the proposal. The Affidavit be filed within three days. In case the Affidavit is filed then the link be made open to enable the Institute to rectify the mistakes and submit the proposal based upon actual income and expenditure of M.B.A course and segmental bifurcation of income and expenditure of Non F.R.A course. So also furnish the explanation to queries raised in letter dated 03/05/2023. The process of re-submission of proposal with rectification be made within two weeks from the date of opening of link. The hard copy of rectified proposal with documents be submitted within one week thereafter.
