The following Institutes mentioned below were directed to furnished the information as mentioned in letters issued to them. The Institutes have not furnshined the information nor offered explanation. The Principal of the respective Institute has sent letter through email seeking permission to withdraw the proposal.

The request for withdrawal of proposal cannot be entertained for the reason the Institution has already submitted the proposal as contemplated u/s. 14(1)(a) of the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees) Act, 2015 & sought approval of fees for the academic year 2023-2024. Once the proposal is submitted the Institute is not entitled to opt for no upward revision of fees as contemplated u/s. 14(1)(b) of the said Act 2015. The contingency as contemplated u/s. 14(1)(b) of the said Act 2015 to opt for no upward revision of fees arose if the institution has decided not to submit the proposal & opt for no upward revision of fees for next academic years as provided u/s. 14(1)(b) of the said Act 2015. Hence the request for withdrawal is rejected.
