The Meeting of the Fees Regulating Authority (constituted under section 11(2)(3)(4) of the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees) Act, 2015) held on **08th October, 2021** in the Conference Hall, Room No. 305, Government Polytechnic Building, 49 Kherwadi, Ali Yawar Jung Marg, Bandra (E), Mumbai - 400 051.

Item No.1: To consider the proposals received from Pooja School of Nursing Beed (RANM0666) & Shubhangi Institute of Nursing School Beed (RANM0667) for fixation of fee for the academic year 2020-21.

Shri. Dattatray Vithalrao Balutkar the President of the Geetanjali Bhauudeshiya Shikshan Sanstha, the Trust running the Pooja School of Nursing Beed appears and submit that both the Nursing Schools are closed down, as the Registrar, Maharashtra State Board of Nursing, Mumbai has not granted

permission to admit students from the academic year 2018-19. In view of this, the President of Trust seeks permission to withdraw the proposal seeking approval of fees for the academic year 2020-21. He further submit that the Shubhangi Institute of Nursing School is close down for the same reason.

He is directed to submit the request in writing with copy of the resolution passed by Trust to withdraw their respective proposals. He seeks two weeks' time to submit the letter of withdrawal with copies of the resolution passed by both the Trust. Put up after written request accompanied with copies of resolutions are received from both the Institution.

Let the follow up action be taken".

Item No.2: To consider the proposal for approval of fees submitted by Shri. Saibaba Nursing School, Kolpewadi for the academic year 2020-21.

Item No.3 To consider the matter of Nalanda Law College, Mumbai regarding the excess fees collected from the students.

The Officials present submit that have recovered Rs. 66,00,000/- over and above the fees approved by the Fees Regulating Authority, from the students and they are ready to refund the amount to respective students. The letter dated 6/10/2021 and Affidavit admitting the recovery of excess fees from the students filed are taken on record. The officials present submit that they are facing difficulty to trace the addresses of students to refund the fees &

seeks time to refund the fees. They submit that due to financial difficulty they be provided time to refund the amount and grant installments.

It was decided to direct the officials of the Trust to deposit the amount of Rs. 66,00,000/- recovered from students over and above the fees approved by the Fees Regulating Authority. The amount be deposited with the Fees Regulating Authority with the list of students, their addresses, phone numbers, and email address, and particulars of the amount to be refunded to each student, so as to refund the excess fees to individual students through Fees Regulating Authority. The amount be deposited with Authority on and before 21/10/2021. On deposit of excess fees, the Authority shall take the decision as to the quantum of penalty to be imposed.

The Officials of Institute and Trust assured to deposit the excess fee recovered from students with the Authority on and before 21/10/2021 along with the list of students with particulars as directed on the next date of hearing.
