"Discussed.

On scrutiny of the proposal, it was notice that the Institution has charged Rs. 8,89,62,851/- excess fee over the fees to be recovered during the financial year 2022-2023. Beside the said amount the Institute has collected Rs. 1,23,29,890/- as other receipts. The said amount need to be reduced from the expenditure incurred in determining the reasonable fees. The Authority is of the view that opportunity be given to Institute to offer an explanation before taking the decision in the matter. It was therefore decided to call the explanations of the Institute. The Institute be directed to furnish the explanation within three days. The Institute be put to notice that failure to submit the explanation the Authority will decide the proposal by treating that the Institute has no explanation to be offered in the matter.
