On 2nd February 2021, the Hon'ble High Court directed to FRA to decide the review applications on merit. Accordingly, review applications are taken up for hearing on merit.

Item No. 2: In the matter of grievance of PG students studying in Dr. Vasantrao Pawar Medical College, Hospital and Research Centre, Nashik.

The attention of the college is invited to the resolutions passed by this Authority dated 25/11/2020 and 18/12/2020. They are reproduced below :

"Read Gov GR No. एमईडी १०१५/ग्र.इ. २६२/१५/ग्रिक्सग-२ dated 2nd September 2020. The Government of Maharashtra has been pleased to revise the stipend admissible to Junior and Senior residents prosecuting their PG and Super Specialty courses. Shri. Dr. Kalidas Chavan, Registrar, Health Science University and Shri. Dr Dange, Representing DMER, shared their views on the subject.

It is, therefore, resolved that all the private self-financed medical colleges/institutes shall take cognizance of said GR and implement it in its true spirit and letter. The grievance, if any, on that behalf can be lodged with DMER/Health Science University."

"In the matter of complaint dated 7/12/2020 received from the students prosecuting PG course in JUU's Indian Institute of Medical Science and Research, Jaina.

The students have raised a grievance that they are not receiving a stipend as prescribed by MCI and Government of Maharashtra. This Authority in its meeting dated 25/11/2020 has clarified that the college has to follow instructions / GR issued and revised from time to time in

the matter of payment of stipend to Junior and Senior residents. This is reiterated again,

Or. Kalidas Chavan, Registrar, MUHS, Nashik has agreed to take up the issue with the said college. The copy of complaint forwarded to Registrar, MUHS, Nashik. The Registrar, MUHS, Nashik may consider issuing the general instructions to all the medical colleges/institutes conducting PG and Super-Specialty courses.

The Resolution dated 25/11/2020 and today's decision be brought to the notice of the college and the students."

It is desired that the college fulfils its obligations to pay the stipend regularly and at the rate declared from time to time by the Government of Maharashtra and other competent authorities.
