To consider the proposal of Aditya Institute Of Management Studies & Research, Borivali, Mumbai (MB3438) for approval of fees for the academic year 2023-2024.

"Discussed.

While scrutinizing the proposal and website of the Institute, it is noticed that Institute is charging/collecting fees over and above the fees approved by the Authority for the academic year 2022-2023. For the academic year 2022-2023, the Fees Regulating Authority has approved


the fees of Rs. 1,54,000/- per student in respect of the M.M.S course run by your Institute. On website, the Institute has notified the fees for the academic year 2022-2023 as Rs. 2,24,465/- per student, which is in violation of provisions of the Maharashtra Unaided Private Professional Educational Institutions (Regulation of Admissions and Fees) Act, 2015. Such act of Management running the Institute is liable for penal consequences as provided u/s 20 of said Act of 2015.

In view of the above, it was decided to seek explanation of the Institute. Accordingly, the Institute be directed to submit explanation within seven days. Failure to submit explanation it will be presumed that the Institute has no explanation to be offered.

Let follow up action be taken accordingly".
