**Item No.4: To consider and decide on letter dated 01/08/2019 received from the Secretary, Khatoon Minority Women's Social Welfare & Educational Society, Malegaon requesting to approve Ad-Hoc Fees for the first year of B.U.M.S course for A.Y. 2019-20 similar to Ad-Hoc fees for A.Y. 2019-20 for B.A.M.S course.**

The college is conducting BUMS (Unani Medicine) from the year 2019-20. This Authority has proposed adhoc fee for this course. It is Rs. 1,00,000/-. Now the institute wants that it should be Rs. 1,50,000/- at par with Ayurvedic course (B.A.M.S) .

This request is not accompanied with projected expenditure etc. There is mechanism to confirm adhoc fee when regular proposal is received after two academic years. That means the college will have to submit regular proposal on 31<sup>st</sup> October, 2020 for approval of fees structure of A.Y 2021-22. While approving fees structure for A.Y. 2021-22 the adhoc fees is re-visited.

If the college is keen to get the adhoc fee increased, then it should submit projected expenditure which shall be a base to interfere with adhoc fee structure already approved by this Authority.

(i) **To consider and decide on email letter dated 26/8/2019 received from the G.H. Raisonni Institute of Business Management, Jalgaon regarding the merger of EN 5105 into MB 5152 from A.Y. 2019-20 (Ref: Item No. 4(iii) in the meeting dated 25/7/2019 & Item No. 7 in the meeting dated 1/8/2019.**

This is regarding merger of Engineering and Management Institute, Jalgaon (EN 5105) into G.H. Raisonni Institute of Business Management, Jalgaon (MB 5152) with effect from A.Y. 2019-20.

Fees for EN course (EN 5105) is Rs. 82,000/- & for MBA is Rs. 85,000/- .  
The fees for management course MB 5152 is Rs. 1,05,000/-.



Now the institute wants that the fees for BE course conducted by EN 5152 (erstwhile EN 5105) shall be declared as Rs. 82,000/-. Infact this fees structure for B.E course has been already approved so question of re-visiting the decision does not arise for AY 2019-20. It is clarified that management can collect Rs. 82,000/- from the students admitted to B.E course for academic year 2019-20.
