Item No.1(i): To consider the proposal for approval of fees of Dr. Ulhas Patil Medical College, Jalgaon run by Godavari Foundation's in respect of M.B.B.S. course (MMBS0011) for the academic year 2022-2023.

The Authority has considered the proposal submitted by above mentioned Institution for approval of fees for the academic year 2022-2023. On scrutiny of the proposal, it was noticed that the proposals submitted by the institution full of discrepancies and deficiencies. It was therefore decided to call the Principal and Chartered Accountant of the Institute to explain the discrepancies and further to produce certain documents as directed vide letter dated 31/03/2023.

None of the Officials appeared on behalf of the institute. The Dean of the college has sent email seeking one month adjournment to make clarification and produce the documents.

The Authority has directed to open the link for online submission of proposals for approval of fees for the academic year 2022-2023 w.e.f. 01/04/2022 and same was kept open till 30/04/2022. At the request received from numbers of Institutes/colleges, the said period was extended upto 12/06/2022. However, the above named Institute failed to submit the proposal within the stipulated period .

Thereafter the opportunity was given to all such institutions, to submit the online proposal on and before 10/08/2022 subject to payment of penalty of Rs. 1 lakh per course who failed to submit the proposal earlier. Thereafter also the said institute failed to submit the proposal. The said Institute has submitted the proposal in the month of January 2023 with penalty that too with deficiencies. The fees of almost all the Institutions barring few institution for the academic year 2022-2023 were decided by the Authority. So also the Authority had open the link for online submission of proposal for the academic year 2023-2024 w.e.f 06/10/2022 and the proposals were directed to be submitted on and before 31/10/2023.

Now the Authority has started the process to decide the proposals for approval of fees for the academic year 2023-2024.

In view of the above, it is not desirable to grant such long adjournment to decide the fee proposal for the academic year 2022-2023.



It was decided to list the proposal for hearing on 13/04/2023 as a last chance to the said Institute.

The Dean of the college, the Chartered Accountant of the Institute and Office bearer of the Institute be directed to appear before the Authority on 13/04/2023 with entire record . Failure to comply the Authority will decide the further course of action.

The Authority has resolved to open the link for submission of online proposals for the academic year 2023-2024 w.e.f from 06/10/2022 & the online proposal were directed to be submitted on and before 31/10/2022. The Institute submitting online proposals were directed to submit the hard copies of the proposal within 15 days of submission of the online proposal with documents mentioned in the checklist.

As per the office note the Institutions mentioned in list Annexure 'A' though submitted online proposal but they have not submitted the hard copies of the proposal as per the instructions contained in the notice dated 04/10/2022. The Principal of the respective colleges were twice informed to comply with the direction and submit the hard copy of the proposal to enable the Authority to process and finalized the fees of the respective Institute for the academic year 2023-2024. However, the Institute mentioned in list annexure "A" have failed to submit the hard copies of proposals.



As per the office note the Institutions mentioned in the list Annexure 'B' though submitted the online proposal but they have not submitted hard copies of the proposals as well as process fees.

As per the office note the Institutions mentioned in the list Annexure 'C' though submitted online proposals but not submitted hard copies of the proposal. So also they have not paid the penalty towards the delay in submitting the proposal.

The institutions mentioned in list Annexures 'A', 'B' & 'C' be informed to comply the deficiencies within one week from the date of receipt of the communication. Failure to comply the names of all such institutions who have failed to comply and remove the deficiencies be placed before the Authority for taking further decision which includes to report their names to the Admission Regulating Authority , to put such institution under "No Admission Category" as well as affiliating Competent Authority as well as concern University for taking appropriate action which includes withdrawal of affiliation and approval to such institutions.

Let the follow up action be taken accordingly."
