

The fees approved be communicated to the respective institutes/colleges. The institutes/colleges be informed that if the fee approved by the Authority is not acceptable to them then individual institutes/colleges may file the Review Application with detailed reasons before the Fees Regulating Authority as per the procedure prescribed within fifteen days from the date of communication of the decision.

Part-II

On scrutiny of the fees proposals received from Spandan Nursing College, Bhandara (RGNM0151) seeking approval of fees for the academic year 2020-21, it is noticed that the proposal submitted full of deficiencies. It was decided to communicate the deficiencies to concerned institutes/colleges to enable them to rectify the same. The office to act accordingly and inform the institute/college to rectify the deficiencies within two weeks.

Part-III

It is pointed out that Gramin Samajsevi Sanstha Trust Kolpewadi, Ahmednagar (hereinafter referred to as "said Trust") runs the following four institutes/colleges:

- 1. Dr. Kolpe Nursing College, Kolpewadi (B.Sc Nursing)
- 2. Shri. Swami Samarth Nursing College (RGNM)
- 3. Shri Saibaba Nursing School, Kolpewadi (RANM)
- 4. Dr. Kolpe Institute of Pharmacy (D.Pharmacy)

The proposal seeking approval of fees for the academic year 2020-21 submitted by Shri. Sai Baba Nursing School, Kolpewadi was considered along with the other proposals by the Authority in its meeting held on 17/8/2021. The Authority has approved the fees to be charged by said college/institute as Rs. 54,000/- per student for the academic year 2020-21.

It is pointed out that in the proposal seeking approval of fees submitted by Shri. Swami Samarth Nursing College, Kolpewadi, Ahmednagar (RGNM0135) run by the same trust, the name of the Principal of said college mentioned as Shri. Patil Chidanand K, who is also shown as a Principal employed during the same period in Shri. Sai Baba Nursing School, Kolpewadi whose proposal was decided by the Authority in the meeting held on 17/8/2021. It is further pointed out that the same person also shown as a person employed as a Lecturer in Dr. Kolpe Nursing College, Kolpewadi running B.Sc Nursing course, the college run by same Trust. Thus, it is pointed out that the same person shown as employed



and paid salary during the same period from three different colleges /institutes run by same Trust. It is further pointed out that there are number of persons employed in one institute are shown to be employed during the same period in another institute run by said Trust and salary was paid to those employees from each of those institutes. The details of such persons are as under:

It is interesting to take note that one of the employee Ms. Vairal Priayanka S whose name is mentioned as a Peon/Ayan, employed in Shri. Sai Baba Nursing School, Kolpewadi (RANM course) also shown to be employed during the same period as a Lecturer in Dr. Kolpe Institute of Pharmacy, Kolpewadi run by same Trust. Similarly, the person by name Chavan Sachin Tukaram which is shown as employed in Shri. Sai Baba Nursing School, Kolpewadi as a House Keeper also shown to be employed as a Head of the Department (HOD) in Dr. Kolpe Institute of Pharmacy, Kolpewadi run by same Trust. Similarly, the number of persons are shown to be employed during the same period in 3-4 institutes and paid salaries from each of such institutes/colleges as per the proposals submitted to this Authority.

In view of above there is a reason to believe that the deliberate attempt has been made to practice fraud upon the Authority in securing approval to fees proposals of said Institutes/colleges for the academic year 2020-21. It is therefore necessary to conduct in depth enquiry in respect of the proposals submitted by the Institutes/colleges run by said Trust. It is decided to recall the decision dated 17/8/2021 to the extent of Shri. Sai Baba Nursing School, Kolpewadi and to decide their proposal afresh along with the proposal under consideration after giving an opportunity of hearing to the Principal of



College, The Trustees of the Trust & the Chartered Accountant who has audited the accounts of the said institutes/colleges and the Trust. Accordingly, the notices be issued to them to appear in person before the Authority on 15/09/2021 at 11:00 am to offer their explanation.

A copy of the minutes of the meeting be forwarded for information and necessary action to The Principal Secretary of Higher & Technical Department, Mantralaya, Mumbai, The Principal Secretary, Medical Education & Drug Department, Mantralaya, Mumbai, The Directorate of Medical Education & Research, Mumbai, The Directorate of Technical Education, Mumbai, The Registrar, Maharashtra State Board of Nursing and Paramedical Education, Mumbai & The MAHADBT, Mumbai.

Item No.4: (i) To consider the request received in the form of a letter dated 20/5/2021 from Matoshri Asarabai Darade Homeopathic Medical College, Nashik to approve the fee structure for academic year 2019-20.

In absence of the proposal for approval of fees submitted by the Institute/college, the Authority is unable to take decision to approve the fees. The Institute/college be directed to submit the proposal in a prescribed proforma along with the requisite documents within 2 weeks. Failure to submit the proposal notice be issued to the Institute/college to explain as to why the penalty be not imposed for not submitting the proposal within the stipulated period".

(ii) To consider the request received in the form of letters from various institutes/colleges running Technical/Health & Science/Agriculture courses to allow them to charge the fee approved as per academic year ie. 2019-20 for the academic year 2021-22
